BE IT FURTHER RESOLVED that Applicant shall pay within thirty days of the date of this Resolution payment of all sums now and/or hereafter due for application escrows as defined in the AJV Engineering, Inc. Completeness Letter dated January 14, 2020 (the "Fees"), and

BE IT FURTHER RESOLVED that if Applicant fails to pay the Fees as required herein, within thirty days of the date of this Resolution, the Board Secretary is

authorized to request that the City Attorney for the City of South Amboy take such action as is necessary and authorized by law to impose a municipal lien on the Premises for such Fees.

BE IT FURTHER RESOLVED, that the application escrow fees must be paid in full prior to the Board accepting any future applications on this property.
