Dear Mr. Wilday:

This office is in receipt of the above referenced City Council Resolution, the proposed Ordinance as drafted by the City Engineer, and a 6/1/10 memo from the City Law Director. Pursuant to N.J.S.A. 40:55D-26, the Planning Board has thirty-five days to make a report/recommendation to the City Council for any proposed Ordinance relating to the City's Development Ordinance. However, in this particular instance our report/recommendation is required to City Council prior to their 6/16/10 meeting to insure continued coverage by those residents within a flood plain.

The proposed Ordinance amends the current City Ordinance regarding Flood Damage Prevention and maintain the standards established by Department of Homeland Security's Federal Emergency Management Agency (FEMA).

We have reviewed the City Council Resolution, the proposed Ordinance as drafted by the City Engineer, and the recommended revisions to the draft Ordinance by the City Law Director, Our review included the current City of South Amboy Master Plan as it relates to the proposed Ordinance. We find that the proposed Ordinance as amended by the City Law Director's memo of 6/1/10 would meet the goals of the current City Master Plan to protect the citizens of the City from flood damage to their property. We find that the proposed Ordinance does not require any modification to the current City Master Plan, but is consistent with its goals and recommendations.

It is recommended that the Planning Board adopt a resolution to the City Council indicating that the proposed Ordinance as amended by the 6/1/10 City Law Director's memo is consistent with the current Master Plan and that the Planning Board recommend its final adoption.
