(referred to in this Agreement as the "Planner").

WHEREAS, the City of South Amboy has designated the Planner to provide special planning services as required by and on behalf of the City and its Planning Board; and,

WHEREAS, this contract is designed to comply with the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-5; and,

WHEREAS, this contract is the result of a fair and open process;

NOW, THEREFORE, in consideration of the mutual covenants and conditions herein contained, the parties agree as follows:

1. The City of South Amboy employs the Planner to provide special planning services to the City Planning Board with his attendance at Planning Board meetings, advice and consulting to the Board, and preparation of any necessary planning reports.

- 2. The Planner shall keep the City advised of the character and progress of his services.
 - 3. The City shall pay the Planner a flat rate of \$1500.00 per month.
- 4. Vouchers for services may be submitted periodically. Each voucher shall be signed by the Planner and shall provide such detail as is acceptable to the Chief Financial Officer of the City. The Planner will maintain adequate books and records indicating the services performed for the City Planning Board and will retain them for a period of six (6) years after completion of the work to be performed, and will make them available to the City or its officials, for inspection, upon reasonable request during that period.
- 5. The City, at its discretion, may vote to cancel this contract upon thirty (30) days' written notice to the Planner. The Planner shall be paid for all services rendered to the date of termination, and for any services the Planner may provide after the date of termination which are necessary to insure a smooth transaction.
- 6. The Planner's response to the City's Request for Qualifications, including all submitted documents are incorporated herein and made a part hereof.
- 7. The Planner will maintain, during the full term of this contract, a policy of professional liability insurance covering the work performed by the Planner and will provide the city with a Certificate of Insurance within ten (10) days hereof.
- 8. This contract is awarded to the Planner pursuant to the Professional Services Exception to the Local Public Contracts Law of the State of New Jersey. The Planner will remain, throughout the term of this contract, licensed as a Professional Planner of the State of New Jersey. The Planner understands that it is unlawful for the City to make payments for services due him, if he is not licensed as a Professional Planner of the State of New Jersey. Therefore, the Planner agrees to maintain such license and further agrees to reimburse the City for any sums paid to him, should these representations prove to be untrue.
- 9. This contract is also awarded as a result of a fair and open process with the Planner being deemed qualified for his professional services to the City Planning Board.

10. The parties have read and fully understand this contract. It is signed and sealed in accordance with New Jersey Law by the duly authorized corporate officers of the City and by the Planner.
